All minor violation court calls are held daily at 9 AM, 10 AM, 11 AM, 1:30 PM and 2:30 PM. Courtrooms CL01, CL03, CL05 and CL07 are minor violation courtrooms and are located on the Concourse Level of the Richard J. Daley Center. Also, minor violations are heard in Courtroom 401 on the 4th floor of the Richard J. Daley Center at 9 AM, 10 AM, 11 AM, 1:30 PM and 2:30 PM.

The major/DUI violation court calls are held daily at 9 AM and 1 PM. Courtrooms 402, 404, 405, 406 and 408 are major violation courtrooms and are located on the 4th floor of the Richard J. Daley Center.

Courtrooms 403 and 407 handle charges of driving while license is suspended or revoked and other related charges. Court calls are held daily at 9 AM, 10 AM, 11 AM, 1:30 PM and 2:30 PM. These courtrooms are located on the 4th floor of the Richard J. Daley Center.

Motions are heard in Courtroom LL04 on the Lower Level at the Richard J. Daley Center. The calls for Courtroom LL04 are heard Monday through Friday at 9:00 AM. Attorneys are reminded that compliance with Circuit Court Rule 2.1 is required.

The Violation Call is heard on Monday through Friday in Courtroom LL04 on the Lower Level at the Richard J. Daley Center at 1 PM.
